IN CONSIDERATION of allowing me to host an event at the Beaver Point Hall, I agree as follows:

1. I acknowledge the contagious nature of the novel coronavirus/COVID-19 ("COVID-19") and that the BCCDC and many other public health authorities still recommend practicing physical distancing.
2. I further acknowledge that Beaver Point Community Hall Association ("Beaver Point Hall"/"the Hall") has put in place preventative measures to reduce the spread of the COVID-19.
3. I further acknowledge that Beaver Point Hall cannot guarantee that I or my attendees will not become infected with COVID-19. I understand that the risk of becoming exposed to and/or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Hall volunteers, and other Hall renters and their attendees.
4. I voluntarily seek to host an event at Beaver Point Hall and acknowledge that I am increasing my risk to exposure to COVID-19. I acknowledge that I and my event attendees must comply with all set procedures to reduce the spread while attending my event, and that failure to observe any of the Hall's policies may result in the cancellation of my event or the removal of myself and my event attendees from the Hall.
5. I attest that I and my attendees:
 - a. are not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
 - b. have not traveled internationally within the last 14 days.
 - c. have not traveled to an area of Canada highly impacted by COVID-19 in the last 14 days.
 - d. do not believe we have been exposed to someone with a suspected and/or confirmed case of COVID-19.
 - e. have not been diagnosed with COVID-19 and not yet cleared as non-contagious by provincial or local public health authorities.
 - f. are following all BCCDC recommended guidelines as much as possible and limiting my exposure to COVID-19.
6. I hereby release and agree to indemnify and hold Beaver Point Community Hall Association harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, negligence or failure to act of the Hall, or that may otherwise arise in any way in connection with any services received from Beaver Point Community Hall Association. I understand that this release discharges Beaver Point Community Hall Association from any liability or claim that I, my heirs, or any personal representatives may have against the Hall with respect to any bodily injury, illness including but not limited to COVID-19, death, medical treatment, or property damage that may arise from, or in connection to, any event or class held at Beaver Point Community Hall. This liability waiver and release extends to the Hall together with all Beaver Point Community Hall Association board members, volunteers, and employees.
